

NOTICE OF SCHOOL BOND ELECTION

PUBLIC NOTICE is hereby given to the qualified electors of Kearney County School District 0503 (Minden Public Schools) in the State of Nebraska (the “**District**”) that a special election has been called and will be held in the District on Tuesday, September 10, 2013, at which time there shall be submitted to the qualified electors of the District the following proposition:

“Shall Kearney County School District 0503 (Minden Public Schools) in the State of Nebraska (the “District”) issue general obligation bonds of the District in a principal amount not to exceed Twenty-five Million Nine Hundred Ninety-five Thousand Dollars (\$25,995,000), for the purpose of paying the costs of purchasing land and site preparation, constructing a new high school building, constructing additions and improvements to the existing middle school and elementary school buildings, and providing the necessary furniture, equipment, and apparatus for such school buildings; such bonds to be issued from time to time as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?”

FOR such Bonds and tax

AGAINST such Bonds and tax

Electors voting in favor of the proposition shall blacken the oval opposite the words “FOR such Bonds and tax” following such proposition, and electors voting against such proposition shall blacken the oval opposite the words “AGAINST such Bonds and tax” following the proposition.

By Mail Election

This election will be an election by mail. All registered voters residing within Kearney County School District 0503 (Minden Public Schools) will receive their ballot by mail and therefore no polling places will be open for voting. Ballots will be mailed by the County Clerk/Election Commissioner of Kearney County between August 21, 2013 and August 26, 2013. Registered Voters who will be absent from their residence during that time the ballots are mailed may contact the County Clerk/Election Commissioner office for assistance.

Voter Registration Deadlines

The deadline to register to vote at an agency, with a deputy registrar, or by mail is August 23, 2013. The deadline for in-person registration for Kearney County residents is at the office of the County Clerk/Election Commissioner of Kearney County at 424 North Colorado Ave., Minden, NE 68959 and Franklin County residents is at the office of the County Clerk/Election Commissioner of Franklin County at

Ballot Return Deadline

Voted ballots must be returned to the County Clerk/Election Commissioner of Kearney County no later than 5:00 p.m. on Tuesday, September 10, 2013.
